

Diablo Valley College Retirees' Association Financial Report

For the Period Jan. 1, 2019 to Aug. 15, 2019

The primary purpose for the DVCRA's fundraising is to award scholarships to DVC students. The association first awarded scholarships in 2008, and we have given out a total of \$91,400 in scholarships through 2019. We award and fund scholarships in the spring, and our major fundraising efforts occur during the summer. Consequently, the funds raised in 2019 will be used to fund the scholarships in 2020.

The following DVCRA financial information is for the period January 1, 2019 to August 15, 2019:

- We have \$21,288 in cash held in our bank accounts at Travis Credit Union and the DVC Foundation.
- Our fundraising activities (including donations, memberships, and auctions) generated \$10,697 available for scholarships.
- We had \$16,877 in expenditures including \$14,000 for scholarships, \$877 for luncheons, and \$186 for office expenses.

The Board has approved 14 scholarships for \$1,000 for 2020. Eight scholarships will go to continuing DVC students, and six scholarships will go to transferring students. This will bring our total scholarships awarded to students to a total *over* \$100,000 since 2008.

As of August 15th we have raised approximately \$11,000 towards our goal of \$14,000 in scholarships for 2020; we need to raise an additional \$3,000 by the end of the year to meet our goal. Please help meet this goal

We want to thank our DVCRA members for their continuing generosity to the students of DVC.

Dick Shoemaker Died April 8, 2019

Richard Shoemaker, retired English instructor, passed away on April 8, 2019. Dick began teaching English and ESL for DVC in 1962. He received both his B.A. and M.A. at San Francisco State University. Dick conceived of the idea of the DVC Forum, which he edited and coedited (with Clark Sturges) for 11 years. He also instituted and taught the journalism class for several years that produced Agapae, DVC's creative arts magazine. In addition, he served as chair of the English division and was the first community college teacher in the nation to be awarded a semester-long fellowship from the National Endowment for the Humanities. Dick was an invited Fellow to the first Summer Institute of the Bay Area Writing Project at the University of California, Berkeley in 1974, a group that has influenced professional development around the country for more than a generation. Dick retired in 1996. He is survived by his wife, Neysa Young, his children, David Shoemaker and Carin Shoemaker, and four grandchildren. A small service was held on campus in April and a tree was planted near the English office in Dick's name.

Bob Hodgson Died August 13, 2019

Bob Hodgson was hired as an art instructor in September of 1965 and taught courses in ceramics,

sculpture and pottery. He initiated the annual pottery sale with the proceeds designated for what was called at the time the DVC "Pot Shop" Trust Fund. A large portion of the department's equipment and supply needs were purchased through these funds. In addition, Bob donated most of his personal work to the college for sale with proceeds to the trust fund. For years Bob created the beautiful DVC plates which were given to the retirees at the annual retirement dinner. Per Bob's wishes services will be private.

Colleague Mark Messenger writes that, "Bob's first priority was always teaching, and toward this end, he was impeccable. He came early, stayed late and returned after-hours with tireless devotion. Most significantly, he painstakingly considered the success of every student: facilities and equipment were maintained with precision, lessons were carefully designed, demonstrations were executed with prodigious skill and curriculum was relevantly sequenced. All these avenues of preparedness lead to students, who were always in anticipation of kindness and magic when Bob was in the studio. As a result, he fostered a unique atmosphere, one of contagious synergy, respect and creativity, perhaps his strongest, and most challenging legacy.

Bill Tarr Died June 17, 2019

Bill Tarr joined the Social Science Department in January, 1956. He attended the University of Missouri for three and a half years prior to receiving his A.B. and M.A. degrees from San Francisco State and his Ph.D. from the University of Sarasota, Florida. Bill retired from DVC in 1988.

Bill loved sailing, history,

teaching, singing, and the NFL. Survived by his wife, Lois Shimizu Tarr; daughters, Jesakka Tarr (Diana Souverbielle) and Annemarie Scott (Steven); Joyce Tarr, mother of Jesakka. Also niece, Marijane Rockers with daughters Stefanie and Tess; nephew, Ron Tarr (Bonnie). In lieu of flowers, please kindly make any donation in Bill's memory to The Choir (in memo) at Saint Andrew's Episcopal or the charity of your choice.

Dave Johnson Died May 8, 2019

Dave Johnson started working as a full-time mathematics professor at DVC in 1981, but had worked eight years prior as an adjunct faculty member. He held B.A.'s in mathematics and psychology from UC Santa Cruz, and a M.A. in mathematics from UC Berkeley.

Dave mentioned that one of the highlights of his DVC career was team-teaching two integrated calculus and physics courses with Rachel Westlake, Oshri Karmon, and Jim Ardini. These courses were funded by the U.S. Department of Education Fund for the Improvement of Post-Secondary Education (FIPSE), the National Science Foundation (NSF,) and the General Electric Foundation. He said that FIPSE reported the project generated the best statistics of any other project. Another highlight was cowriting the liberal arts math textbook Mathematics a Practical Odyssey with Tom Mowry.

John Henry Died May 29, 2019

John began his career with the Contra Costa Community College District in 2007 at Los Medanos College. He worked as an adjunct instructor in the Appliance Service and Air Conditioning and Refrigeration programs.

John was hired as a full-time instructor at Diablo Valley College in the Electronics-Electricity program in 2012. Prior to that John worked at PG&E as an engineer. John was a dedicated instructor who worked hard to have his program moving in the right direction with successful graduates. John was always available to help students, not just with their studies, but help them figure out life issues as well.

John is survived by his wife of 43 years, Marcia; his son, Josh; and his daughter, Amanda.



B. Wray Parr Johnson Died May 21, 2019

B. Wray Parr, Central Services Supervisor, began her career with at Contra Costa College in 1952. She worked in Admissions and Records for three years, and, after three children, returned in 1959 to work in the President's Office with payroll and purchasing duties. In 1963, she transferred to DVC and served in a variety of positions in payroll and purchasing, and retired as Central Services Supervisor at DVC in 1988.

Wray is survived by her brother Bernie; husband of 65 years, Emmett; three daughters, Vicki (David/deceased), Cristi (Joe) and Lori (Ken); seven grandchildren, two greatgrandchildren, as well extended family and many friends. In retirement, Wray could be found in her kitchen cooking up something wonderful, in case a small army stopped by; or traveling the country in their 5th wheel meeting new friends all along the way.

DVC RETIREE, CHERYL SUNDARI DEMBE, RECEIVES HER DOCTORATE ~~ 50 YEARS AFTER COMPLETING IT.

Editor's note: The DVCRA Newsletter does not typically write features about individual members, but our colleague Cheryl Sundari Dembe's story, is so extraordinary that I thought our readers would appreciate it. Her case received and merited attention by national and local news agencies. The story below and many of the quotations are a compilation from *Chemistry News, NPR.org, the San Jose Mercury,* and the *University of Chicago News.* In addition, Sundari's story has been covered by the *New York Times* and the *Royal British Society's Chemistry World Magazine.* ~~ Laury Fischer

In June, 2019, Cheryl Sundari Dembe received an extraordinary honor: the University of Chicago, having revisited research Dembe completed more than fifty years ago, awarded her a PhD in Chemistry after doing a thorough review of her work and apologizing for their behavior towards her. It was a remarkable and nearly unprecedented pivot for the University.

Dembe arrived at the University of Chicago in the late 1960s: It was a time of great social change, but significantly, women were routinely shut out of positions of power – in business, in medicine, in academia.

Dembe began her serious research exploring a complex topic: how two helium isotopes, Helium-3 and Helium-4, have profoundly different behaviors when cooled. She succeeded in sustaining the particles at nearly absolute zero, and also found a novel approach using the magnetic properties of the particles to determine their temperatures.

After two and half years, her advisor, Lothar Meyer, concluded that her research was "ready": Dembe had good enough data to start writing her thesis and she expected to complete it in six months.

Ten days later, Meyer died; Dembe's world changed in that moment.

"I was devastated by his death, but still wanted to complete my research project by writing and publishing my work," she said. "No one I knew was stepping up to be in charge of me. You can't just write up these things without a faculty adviser."

The University offered her a replacement adviser in a related research group, but the new advisor told her, "Sorry, we won't have a woman." Dembe added, "That was the last time anybody really talked to me. Not one person at the University was willing to look at my years of research. Not one person."

Dembe left Chicago, moved to California and brought all of her research with her but with no idea how she would use it. She was hired as a full-time chemistry professor at DVC in 1974. As we know, she had fulfilling career here in Pleasant Hill, retiring in 2008.

Twenty years ago on sabbatical leave from DVC in 2000, Dembe discovered the work of a chemist, Douglas Osheroff, who had eventually won the Nobel Prize in Physics for the discovery of superfluidity in helium-3, and whose work was extremely close to Dembe's at the University of Chicago. She contacted Osheroff who was at Stanford at the time, and it turned out that he had heard about Dembe's research group in Chicago and her project there. He said, "You should have gotten your degree with Chicago, I'll support you in that," Dembe recalls.

Her appeal, even with Osheroff's support, to the University of Chicago in 2000 was ignored. Years later, emboldened by the #MeToo movement in 2018, Dembe tried again and wrote to University of Chicago President, Robert Zimmer. And this time the results were astonishing: the University decided to look into her claim. Vice Provost, Jason Merchant, saw that her case raised important issues and involved improper behavior toward a student and warranted a thorough review by faculty as well as outreach from the University's Title IX Coordinator to offer additional support. He re-opened her case.

The university team faced a daunting task: Dembe's data, compiled before computers, bore no resemblance to what research looks like now. She had much less data than required now, and had conducted her calculations on a *slide rule*. Pages had been copied on ditto machines; photocopying was not yet widespread.

"We tried to get as much information as we could," said Philippe Guyot-Sionnest, professor of Chemistry and Physics, who headed the committee investigating the claim. "One fortunate thing is that she kept very good quality notebooks about her day-to-day work in the lab. We were able to read that."

After an extensive review of Dembe's old lab notebooks, despite a missing thesis, the University committee judged her work worthy of a doctorate, a particular rarity because of the absence of a dissertation as well as a distance of five decades.

Movingly, Andrei Tokmakoff, chair of the University Department of Chemistry, wrote, "We thank you for presenting us with an opportunity to partially rectify these mistakes of the past."

Vice Provost Merchant added, "We offer our heartfelt congratulations to Cheryl Dembe on her academic work, as well as her inspiring persistence in pursuing the degree that her scholarly work has earned. . . . It's clear that she did not receive the support that all students should expect when she was here, and the University sincerely regrets the treatment she received and the decades it has taken to rectify the effects of that mistreatment. We are very pleased to be able to recognize, albeit belatedly, her academic accomplishments now."

Dembe's incredible accomplishment was further recognized when the University of Chicago flew her and her family back to Chicago to receive her doctorate and walk in her academic hood in the university graduation ceremony in June.

As a result of the recognition that her story has generated, Dembe has spoken or has been invited to speak at the American Association of University Women, the American Chemical Society, and the Center for Gender and Sexuality at the University of Chicago.

"It is utterly amazing," Dembe said. "I believed in the University as an institution with integrity, with the need to correct the error. And they did. My sense of who and what I am is shifting. There's a ripple that goes out in the world when we do things like that, which is far bigger than you would ever guess. There is potential for healing beyond myself with this story. Now that I've finished my career, and have my doctorate, I can start my life anew.

"This whole unfolding has firmly convinced me of the illusory nature of this world, and that there is no order of difficulties in miracles. Kind of interesting unfoldments after eleven years of retirement! Looks like I'm starting a new career."

MAKE IT COUNT: An Easy Way to Donate to Our Scholarship Fund

There is a wonderful method to donate to our DVCRA Scholarship Fund and at the same time qualify for *tax-free* contributions from your IRA account. If you designate the DVC Foundation as the recipient of a *Qualified Charitable Deduction (QCD)* then our scholarship fund benefits and you get the tax benefit. (Just be sure to write DVCRA Scholarship Fund on the memo line of your check).

<u>Here's how it works</u>: Each **IRA** owner (age 70.5 or older) who must make a Required Minimum Distribution (**RMD**) can annually transfer any amount up to \$100,000 directly from their IRA to qualified charities, e.g. the DVCRA Scholarship Fund – which qualifies as a QCD. The money you allocate to this QCD will be excluded from income, and hence *not taxed*. In addition, these funds can count toward the required minimum distribution. Funds must go *directly* from an IRA to the charity, either via a transfer by the IRA custodian or by a check from the IRA to the DVC Foundation (or other charity).

Why Bother? Aren't Charitable Contributions Deductible Anyway?

The U.S. government designates a standard deduction to be subtracted from our income, and it is not taxed. If we have MORE than this amount in allowable medical bills, taxes to states, charity contributions etc., we can use the larger total instead of the standard deduction. Usually charitable contributions are deductible only to the extent that they cause our total deductions to exceed the standard deduction (which is \$27,000 for a senior couple in 2019). However, the Tax Cuts and Jobs Act of 2017 also made it more difficult to exceed the standard deduction by limiting what we can deduct from our taxes.

The good news is that charitable giving via a **QCD** is **100%** excluded from taxable income, and your standard deduction or other itemized deductions can still be taken. Be sure to consult your tax professional for make sure these rules apply to you and that you understand them. But please consider making the DVCRA Scholarship Fund the recipient of these qualified deductions. Contra Costa Community College District Chancellor Fred Wood To Retire This Spring

Editor's Note: Information for his article was taken from Annie Sciacca's reporting in the East Bay Times and Dr. Wood's emailed message to the entire District.

This past July, Fred Wood, Chancellor of the Contra Costa Community College District since early 2017, announced that he will retire in March, 2020.

"After considerable and thoughtful deliberations, I have decided to retire after a four-decade career in higher education due to increased personal obligations and because I firmly believe the District is ready for new leadership," Wood said in a written statement.

At our luncheon Wood spoke glowingly of his time at DVC as a student and remembered especially fondly his chemistry classes and instructors. From DVC, he transferred to UC Davis where he earned his undergraduate and graduate degrees.

Wood succeeded Helen Benjamin who served as Chancellor for twelve years before retiring.

Wood's retirement announcement is in the midst of turmoil in its leadership at Contra Costa College. Three top administrators at the college had been put on leave while an investigation was pursued, and in August, 2019, President Katrina VanderWoude, resigned from the college.

At upcoming Board meetings, the governing board will discuss recruitment of the district's next chancellor in the hopes of finding Wood's replacement before he retires.

In his letter to the District community, Chancellor Wood expressed his appreciation and gratitude to the Board, local businesses, donors, elected officials, community members, and numerous organizations, faculty and classified staff, and especially the students of our three colleges. "Thank you all for giving me the great honor and privilege to serve as your Chancellor. I deeply appreciate the trust you have expressed in my leadership. There is still much I hope to achieve over the next months, and I look forward to working with all of you to accomplish great things."
